<p><b>POSITION PURPOSE SUMMARY:</b> There is a relief position offering flexible scheduled hours. Schedule will vary according to requirements and responsibilities. Shifts include a ½ hour paid meal break where applicable. Supervisor will set the hours of work and work schedule. Shifts can include days and weekends.</p> <p>The Community Participation Supports (CPS) Case Worker will plan and implement individual, goal-centered programs and offer support in workplace settings for adult with developmental disabilities participating within the CPS Lawson Ministries program and in the community. - Working co-operatively with the day program team, support networks and as needed residential counsellors in providing co-ordinated and consistent approaches to persons supported

- Current First Aid & Cardiopulmonary Resuscitation with Defibrillation training and current Non-Violent Crisis Intervention Certification required
- Medication administration training and experience necessary
- Non Violent Physical Crisis Intervention Certification required
- Provide an original copy of Criminal Records Check (CRC) with vulnerable sector screening secured through either the national Canadian Police Information Centre (CPIC) or through a local police detachment; Note: A satisfactory criminal background check is required.
- Must have valid Ontario Class "G" or G2 Driver's license (accessible to a vehicle may be required)
- WHIMIS (2015 Workers) certification
- Additional trainings required by the Salvation Army
